The following action was taken at the Board of Natural Resources meeting on August 26, 2025.

The Board approved the minutes of the board meeting on June 24, 2025.

The Board adopted the Resolution to approve the Proposed Amendments to the Coastal Incentive Grant Program Description, Chapter 391-2-5-.01 through 391-2-5-.15.

The Board adopted the Resolution to approve the Proposed Amendments to the Rules for Water Quality Control, Chapter 391-3-6.

The Board adopted the Resolution to approve the Proposed Amendments to the Rules for Safe Drinking Water, Chapter 391-3-5.

The Board adopted the Resolution to authorize the Commissioner to seek State Properties Commission approval to enter into a five (5) year Lease Agreement with the United States Postal Service, Sapelo Island, McIntosh County.

The Board adopted the Resolution to authorize the Commissioner to seek State Properties Commission approval to amend a twenty-five (25) year lease agreement with Georgia Power Company to construct a maintenance and residence facility at Dames Ferry Campground, Monroe County.

The Board adopted the Resolution to authorize the Commissioner to seek State Properties Commission approval to enter into a twenty-five (25) year Ground Lease with Dawson County for a telecommunication tower by the State Properties Commission and General Assembly in Dawson Forest WMA, Dawson County.

The Board adopted the Resolution to authorize the Commissioner to seek State Properties Commission approval to enter into an agreement with the Wayne County to lease 2.00± acres Oglethorpe Bluff Landing, Wayne County.

The Board adopted the Resolution to authorize the Commissioner to seek State Properties Commission approval for the Granting of a Revocable License Agreement and Permanent Easement of up to 0.52± acres by the State Properties Commission and General Assembly to Jefferson Energy Cooperative at McDuffie Public Fishing Area, McDuffie County.
