

## CHARTER/GUIDE LICENSE INSTRUCTIONS

For your convenience, licenses may be purchased three ways, **by mail, email or in person** at the Coastal Regional Headquarters in Brunswick.

\*Purchasing **by mail**, please send the following items:

- FULLY completed license application. Please include vessel State Registration # or USCG Documentation # on application.
- A photocopy of your driver's license or state-issued identification card.
- If purchasing the optional customer license, a copy of your USCG license is REQUIRED.
- Check or money order payable to the Georgia Department of Natural Resources. Don't forget to include the \$5 transaction fee **per license**. If paying by credit or debit card, provide all information on the Credit/Debit Authorization Form.
