The following action was taken at the March 23, 2021 Land Committee meeting:

The Committee recommended that the Board adopt the Resolution to authorize the Commissioner to seek State Properties Commission approval of the Renewal of License No. DACW21-3-21-0026 for Recreational Purposes 25-Year License Agreement), U.S. Department of Army, Corps of Engineers (COE), 11.19± acres of real property at Lake Hartwell Reservoir, Hart County.

The Committee recommended that the Board adopt the Resolution to authorize the Commissioner to seek State Properties Commission approval of the Renewal of Lease No. DACW01-1-21-1033 for Recreational Purposes 25-Year Lease Agreement, U.S. Department of Army, Corps of Engineers (COE), 47.80± acres of real property at Walter F. George Lake, Sandy Branch Park, Clay County.
