The January 31, 2020 meeting of the Wildlife Resources Committee was called to order by Board Chairman Bodine Sinyard. Chairman Sinyard called on Dwight Evans, Chairman of the Wildlife Resources Committee. Mr. Evans called on Ted Will, Chief of Game Management.

Mr. Will stated the proposed amendment to Chapter 391-4-2 is needed to establish hunting regulations on a new wildlife management area, Ceylon WMA, in Camden County. Public notice ended on January 10, and four (4) comments were received and are supportive.

A motion was made by Ms. Addison, seconded by Mr. Jones, and carried unanimously that the Committee recommend the Board approve the proposed amendment to Rule 391-4-2, Hunting Regulations pertaining to Ceylon Wildlife Management Area, as presented.
